Dear Dick:-

Thank you for your punctilious reply to my first letter. Your kindly and prompt interest was much appreciated and much more so that newspaper clipping from the Call Bulletin of October 10, 1925. Although I have never kept a scrap book THAT is something that I shall value very highly and thanks, again, for letting me keep it. I was proud to show it to the fellows at KHK and, of course, they were all intrigued. Despite our never having kept a scrap-book we did have several albums of pictures from my quite lengthy sea-going experiences. These were stored in bottom drawers and, unfortunately ALL were totally destroyed in that April 1st 1946 tidal wave which wrecked our beach-shack home. Had they been stored higher up -- say, in the ceiling (!) they might have survived. As it was all my photographic memoirs of my five years on British vessels, my long trip on the RESTORER (WIU) with early pictures of the Islands and, more insteresting of cable repairing on the ship and the entire Cable-Company-owned milieu at Midway, were all gone. Likewise the photographic records of my 2 years on WAA running up to Anchorage & way ports up & down in Alaska -- all gone.

Well we had two destructive tidal waves since then but did not have to do any houserebuilding, although the 1952 one took thousands of tons of sand from our beach in front. It has never returned and we had to put in a sea-barrier.

Congratulations on your reaching 75 and for looking as well (and handsome) as you do in those pictures (at KPH) in Ports of Call and for being able to work, even part-time, in the Marin County Sheriff's Department. I'm a great believer in staying at work.

At the time of the Oct 10, 1925 picture I was still pretty much of an English, newly acclimated, immigrant, although I gained my full citizenship papers earlier in that same year. I suppose I have my English accent still, although I do not realize it myself until I hear myself on a tape recorder. The reason I'm working at KHK is chiefly because the entire former-glorious business at Kahuku (KU) (which made around \$200,000 monthly in 1965, dwindled to nothing by 1967 with the installation of two multi-channelled submarine cables and the advent of the Satellites. RCAC petitioned to close KU in 1967 and the FCC finally granted this in May 1968. This left the Marine Facility alone and only 5 men were retained chiefly because the others simply could not handle marine work. Hence, KHK gets short and even before KU was closed down, I was hired back, after 42 years of retirement in 1967, and worked 7 months. At that time it was scarcely worth it as my Social Security was docked and the additional taxes were high. I was called back because I am the good Operator which YOU demanded of all those fellows that worked on the Matson ships in those far-off 1920s. So this time, when one of their best men became so sick that he almost died, I was called back again on June 22 this year to allow the others to take vacations after theyd offered the job to the former KU unemployed who had seniority over me and who frankly gave up because they couldnt handle it. For you must know that KHK is now, at long last, making money enough to support itself -- though I dont know how RCAC figgers on THEIR BOOKS at NY. In any case I'm still there and the length of time I'll be there will depend on whether this very sick man will be able to resume duty. He's still very weak -- he almost died 2 months ago, lengthy kidney trouble, but is going to try out on a part time Maintenance & Repair basis starting Oct. 1st. They give me the most difficult watches which are, generally the day watches from 8 to 4, although I've worked quite a few 4 to Mids and I say proudly that I'm more than able to withstand the demands that a one-man madhouse can put upon me !! Also, I dont lose any Social Security NOW I married in 1939 -- not the same gal I fell for in 1923 in HU while on the being 72. WIU, but a Western girl, born Montana, raised in Seattle. It has been a pretty fine deal - at least for me;

OVER

Here, my boasting ends. Actually, I've been, I suppose, pretty much of a failure most of my life except for being a good Marine man. When <u>Red Roy</u> took me into the Point to Point business in June 1927, they soon found that, while FAIR, I didnt have the caliber for a really 1st class PTP man as my co-ordination with the typewriter was never and never will be, perfect. I could read the slip OK, also punch a Kleinschmidt, but even to change to another typewriter was always a source of trouble to me, so, come 1931 when RCAC was using the hatchet and my "contract" expired I was dropped by jolly old Thompson H MITCHELL for whom I've always entertained considerable respect and not a little affection.

Ultimately (after 2¹/₂ years on Honolulu's Police Department, Radio Division) I ended up with one of the worst outfits possible -- GLOBE WIRELESS and spent almost 20 years there ending up in the City Office as Commercial Mgr and Asst. District Manager. It was hopeless in Globe -- always was after the grand Old Man Robert Dollar died. They never spent a nickel on the system and we sold our personalities, where we could, against the superb REAL mechanized service being offered by RCAC and MacKay. Finally I quit in disgust and went to RCAC as Relief Marine Operator (3 days per week) and Relief Technician downstairs (KU) two days per week. By that time I was 62 and nobody at KU needed to fear I might take their jobs or anything like that, so I can certainly say these were about the happiest of my life. They even re-instated me in their Retirement System in view of my former 4 years with them and upon fetirement at 65 I got a "pension" of \$7.60 per month plus hospital bene-This is enough to buy 1 fifth of Johnny Walker per month ! Fight months after I fits. quit, Globe was absorbed by American Cable (I.T.T.) and most old-timers proved eligible for pensions. I might have kicked something into the river but later found that this pension was based on some deduction from Social Security or rather they deducted a portion from the pension commensuarble with the SS a pensioner was getting - so I found I hadnt lost much ! Anyhow, I'm not sorry -- at least not yet ! Our beach property here was large enough to install a spare rental cottage. This has been continuously occupied by good tenants and brings in a regular monthly consolation for self & wife.

During my stay with Glone I was "Chief" at Kaena point and had the job of restoring the station to full activity in 1945 building up eight transmitters from scratch and putting them on the air. Early in 1946 they sent down some other guy to become Chief but he took the passage money & went on a binge, so I stayed on, with 3 assistants until 1951 when a real engineer came down (they were attempting multi-channel stuff, filters etc in a cheap way) and took over. Not wishing to hurt my feelings they gave me the job in the City Office and here I was out on the street fighting for business against fellows like Geo. Blackmore and Reginald Goring. I stuck it out until 1959 and whenever the DM -- a hell of a swell guy went on 3 months vacation, I had to run the goddam place -- and did. Had to fire several guys too !! Oh Well.

In connection with your research on early "wireless" in the Tslands, on my last day off, I visited Hawaiian Telephone's Library and was given access to a fantastic hoard of material chief of which was John Balch's Scrap Book. From this I found you were correct. United Wireless had had so much trouble with fake stock selling, decided to open their Island activities in 1899 by making some kind of agreement with lee de Forest and the outfit down here (inspired by a Honolulu resident known as F.J. Cross) was floated under the name of De Forest. Despite this, Cross sent for Marconi experts to select points on the various isles to open stations. A bubonic plague delayed arrival of the Marconi "experts" but they got down late in 1900-1901 set up the staticns at the points you mentioned AND NOT A GODDAM STGNAL WAS EVER PASSED BETWEEN THEM. Late in 1901 another "expert" from Marconi named Gray used a kite and portable transmitter and changed locations of nearly all the stations and some kind of a half-effective communications system was started. This failed financially 2 or 3 times, was refinanced, once by the Sugar Plantations, again by the Govt (Hawaiian monarchy) and then went FOOF again. Then John Balch bought it out and finally got the system (inter-Island) working around 1908. I imagine this would be when Tsbell first came although there was no mention of him I could find in Balch's Scrap except that he was employed by United Wireless in San Francisco and made a public statement, printed in SF Examiner. Of course, we live 40 miles from Honolulu & I could only spend about an hour there.

All of what I've told you is to be found in THE STORY OF THE HAWAIIAN TELEPHONE CO but not in the detail that it is found in Balch's Scrap Books and in the various invoices and expense accounts, minutes of meetings -- in which Isbell's name DOES crop up more than once. But it would take many weeks of research to get it all in order.

Actually, in the Scrap Book a clipping from the Honolulu Star-Bulletin of October 14, 1912 states that Arthur Isbell and wife, of the American Marconi Wireless Telegraph Co., arrived in the Islands to investigate certain matters in connection with various real estate companies for the construction of an a Trans-Ocean Radio Stations of gigantic power. He came on SS STERRA and apparently did not stay very long - believe he left on the same vessel when she returned to SF. This article mentions that Tsbell had been in the Islands "some years previously" and had NOT, at this former time, been connected with the Marconi Company. The amazing part of the whole Transoceanic picture is that the Federal Telegraph Company, using the Poulsen arc, commenced building a station near Kaneohe (actually at Heeia). This was reported in THE ADV RTISER, June 3 1912. Early Sept, 1912 clippings claimed Fed. Telegraph Co had made many successful night time transmissions between HCNOLUL and SF and "officially" opened a night service between the 2 cities on September 4th, 1912. On Sept 6, the Marconi Co brought two different suits against Federal Telegraph for infringements of patents but could not close them down. Apparently it didnt "faze" Fed.Telco. Sid Maddams was the Manager down here at that time as he was many years later when KacKay Telegraph was activated. The US Govt completely bought out the Federal Telegraph Stations here during the War No I and never returned them. When Fed.Tel's descendant MacKay re-opened here (with Sid Maddams as Manager) by that time vacuum tubes had made the Poulsen Arc obsolete but Maddams actually exchanged messages with Washington DC from Honolulu (night low freq) before the huge Marconi Station was built of to

It was built, finally, and formally opened Sept 24 1914; Edmond Slaughter, Engineer in Sharge at Kahuku and theres pictures with hundreds, headed by Governor Pinkham, shown in the clippings in Balch's Scrap Book. Well, Sid Maddams died about 6 or 7 years ago and Haraden Pratt, whom you mention in your letter, died three weeks ago.

This brings us down to the Wireless Pioneers: It seems that I know at least 15 or 20 of the fellows in the organization and that I "ought" to belong. However, I am NOT a "ham" and am far too deeply involved in other things -- have been for years -- to ever become one. I hesitate to join because I might become "involved" which I simply cannot do; yet if I dont become involved, what would be the use of joining ? Does this S.O.W.P. mean so much to you that my membership is important ? If so I'd be glad, indeed, to send in the necessary -- but dunno if I can fill in the application accurately. I have no copy number or other info to prove when I got my first license. In the U.S. my first license was given in S.F. around late 1914 or early 1915 when Woolverton was the Dept pf Interior's Chief Inspector and Ellery W. Stone his Assistant - this long long before FCC. But I believe I have my first (and only) English license issued in November 1913 - its probably in our Safe Deposit box. IF this sick man returns and is able to make it, T MAY take a run up to SF to hear some of their Opera Season. T was there on the first night Sept 25 1923 when they first opened, also 2nd and 3rd nights and have been many times since BUT IF THEY WANT ME to continue at KHK, I will of course, stay on there, as long as needed

H ave no records whatsoever of my U.S. Licenses. Only know my first one was early 1915 in San Francisco when Woolverton, Ellery W. Stone & Miss Frost were running the Dep. of Interior Office that administered all Wireless doings. I received my very first license in November 1913 in Liverpool, England and believe I still have that at the bottom of some Safe Deposit vault in Honolulu - which is an 80 mile round trip drive from our home. Working, as I have been at Kahuku. (KHK), this is something we cannot do without a day or so "off". Will try to get you the info soonest. Let me know what you will "settle for" as I may not remember all the call signs and exact dates I was on various ships. Removed from SS Maui in June 1927 to work in Traffic Department RCAC at 20 Geary Street, San Francisco.

Was on the Manila circuit most of the time and do not remember the call signs of the stations we were keying. However the San-Francisco-Honolulu power station signed KGI, as I recall.

Transferred to Hawaii in early 1928. By this time High Frequencies were being established and it is impossible to remember the call signs of the stations we controlled from the Point to Point Office. The Low Frequency Alternator station used the call KIE, if I remember correctly, and was still in use when my contract expired and I was "laid off" in February, 1931.

From May 1932 until September 1934, I was employedby the Honolulu Police Department solely for the purpose of their being able to hang my Radio License at the location of Police Radio KGPQ.

In 1935 and 1936 I was working for Press Wireless in Honolulu. Again, I cannot remember the call letters of the stations we controlled or copied. Believe one of them was KOS.

From 1936 to 1939 was radio Operator on the U.S. Lighthouse Tender KUKUI, WWIX.

In July 1939, I went to work for Globe Wireless at their Kaena Point Station. There we acted as PTP Operators as well as shift-engineers and Marine Radio Telegraphers. The Marine Station signed KYG but this facility was closed down shortly after the outbreak of World War II -- I mean the entrance of the United States into World War II on December 7, 1941. I remained at the Kaena Point Station, with the exception of two years (1943 and 1944) until 1951. During this period the call letters of the various frequencies in use changed from simple calls like KMU, KDO, KKW, KKZ etc to a combination of Letters and numbers, such as KUH-43, KUH52 eta.

Early in 1952 T was transferred into the City Office of Globe Wireless in Honolulu but since the control of the Kaena Point transmitters had been shifted to that office, again my license hung on the wall there.

I stayed on in administrative and commercial functions at Globe, utilizing my license several times a month for part time relief etc, until July 1959.

July 5, 1959, T returned as a Marine Telegraph Operator and relief Technician at KHK, working KHK three days a week and down stairs with the PTP transmitters the remaining two days.

Retired November 1st, 1961. Have occasionally been recalled in an emergency for relief work at KHK.
